

## Warranty Card

Strobes N' More LLC warrants products under the "Strobes N' More" name against defects in material and workmanship. This is if the product has been installed and operated per that specific product install guide and used per its intended purpose. During the warranty period, Strobes N' More LLC will repair or replace (at its discretion) any product which demonstrates a defect in material or workmanship. The customer is responsible for returning the product to our facility located at 81 Tom Harvey Rd, Westerly, RI 02891. The package must include a [Repair Form](#). Strobes N' More LLC will cover the return shipping costs for any item covered under this warranty. Non-warranty items and customers located outside the continental USA will be responsible for all shipping. If the warranted product has been discontinued, we will replace it with a similar product of equal or greater value or give you a pro-rated refund of the lesser unused months.

The above warranty is between the original purchaser only and Strobes N' More LLC. Strobes N' More LLC will not be held liable for any incidental or consequential damages and assumes no responsibility or liability for expenses incurred in the removal and/or reinstallation of products requiring service and/or repair; nor the packaging, handling, and shipping to our facility for warranty work. This warranty is not applicable to any product that has failed due to abuse, misuse, improper installation, excessive voltages or modifications to the product that affects it adversely. Any items not used in accordance with its intended purchase will not be covered under this warranty.

**Condensation** within a lightbar is a normal and natural occurrence due to the temperature and dew point fluctuations within its enclosure. Any atmospherically vented body will undergo normal condensation cycles and with the case of a lightbar, moisture is visible on the outer lenses. The product has been designed with this phenomenon in mind and therefore all internal components have been selected or coated so that this condensation has no impact on the functionality or longevity of the lightbar.

Below is a common list of things that void the warranty. Please take note:

- **Excessive twisting of wires** exiting the light can cause them to loosen and allow moisture and excessive heat buildup causing the fixture to fail.
- **Cutting wires too short** We send all LEDs out with a minimum of 7" of wire. If you cut them too short, we can't test and therefore can't warranty the item.
- **Excessive use of heat shrink tubing** can cause overheating of the wires and loosening of the solder inside the light thus causing the failure. Use wire loom instead which causes no damage.
- **Improper fusing** Properly sized fuses will protect your LED's against damage and fire.
- **Corrosion** Clean lights with warm soapy water periodically to remove salt and other particulates
- **Paint** Do not paint or modify any part of the product.
